

2016 Rifle Section Meeting - Minutes

1. Call to order 2:12pm

2. Minutes from last meeting

- no minutes available
- a committee was supposed to have been struck to review/ update sporting rifle rules in the past year. There was no progress in 2016. Several members within the assembly said they would proceed with the review over the next 12 months.

3. Information from the Chair

- the current rifle rep on the executive is Asmir Arifovic.
- SFC Domestic requires a full accounting of the 2016 National Rifle Championships. The Match Director agreed to this request.
- the National Officials Development Committee (NODC) current rifle rep. is Steven Spinney. This individual is appointed by the Exec/BoD . There is a rep. For each section (Chaired Dale Caswell)
The function of the NODC is to ensure that there is an adequate number of qualified officials to run shooting events from the club, provincial and National Championships. The committee also supervises the nominations of CDN ISSF officials for large ISSF events.
- there is a call for volunteers for the Domestic Affairs Committee (DAC) and the EC. These volunteers coordinate officials, coaches encourage club activities.
This committee has 3-4 teleconference calls per year. This past year.....there have been no calls. No committee !

4. Location of 2017 Nationals.

- a call went out for any club in Canada to host the 2017 National Rifle Championships. There were no submissions from the assembly.
- "on behalf of the Toronto International Rifle and Pistol Club.... A nomination was proposed. "
- there was no discussion.
- a unanimous vote in favour. CARRIED

- a proposed date of the first weekend of Aug 2017 was proposed. Information from the floor suggested that this date is subject to change pending the confirmation from the other shooting groups.

5. Election of the Rifle Section Chair- papa Arifovic expressed his regret.....that 2016 would be his last year as Rifle Section Chair.

- a nomination of Lisa Deneka (Manitoba) came from the Chair.
- further nominations from the floor was solicited . No further names came forth.
- by acclamationLISA DENEKA IS THE NEW RIFLE SECTION CHAIR !

6. New Business

- Canada Games - how can provinces get involved in the process for the next Can Games? CAN SOMETHING GO UP ON THE SFC WEBSITE ? Provinces would like to assist the bid committee/organization.
- Coaching pathway - how can coaches now move forward from now on ? CAN SOMETHING GO ON THE WEBSITE? What is the current pathway for new coaches? CHANTEL SPICER, B.C. IS THE NEW COACHING CO ORDINATOR.
- at HP meeting ask the question...." How can we assist juniors in the process of making the National Team. " The current system has little information/ for juniors.
AT THE HP MEETING.....IT WAS DECIDED THAT ALL PEOPLE WHO PAID THEIR \$25 TEAM FEE, THEY WOULD AUTOMATICALLY BE CONSIDERED FOR NATIONAL TEAM STATUS (once the names and money had been sent /acquired by the SFC office)
The ISSF JUDGE(s) would send names and scores to the office and sign off on all names on the results.
