



## CALL FOR NOMINATIONS ATHLETE, PTSO, RIFLE, PISTOL, SHOTGUN COUNCIL DIRECTOR POSITIONS

The Shooting Federation of Canada has a total of five (5) Council Director positions. All five (5) Council Director positions are up for election in 2023 as the Shooting Federation transitions fully under its new bylaws at the 2023 Annual Meeting of the Members.

Election to be held at the 2023 Shooting Federation of Canada Annual Meeting of the Members

Application deadline: August 26, 2023

### Nomination Guidelines:

- Nominees must be nominated by two current members in good standing of the SFC
- This application form is for Council Director nominations
- The nomination form must be completed in full by both the nominators and nominee, including a ONE-page maximum resume or bio and jpeg photo of the nominee

### Director Eligibility Criteria

- must be a member in good standing of the SFC
- must be a minimum of 18 years of age
- must have the capacity under law to contract

### Nominee Expectations

It is expected of the nominees that they will:

- Be willing to serve on the SFC Board of Directors, if elected
- Have read and understood the [SFC Directors Agreement & Guide](#), which you will be required to sign if elected
- Will complete Respect Group Abuse & Harassment training as requested, if elected
- Will complete a Police Record Check as requested, if elected

### Council Director Position

- The new SFC governance model includes an Athlete Director, 3 Sport Directors (Rifle, Pistol, Shotgun) and a Provincial / Territorial Sport Organization (PTSO) Director – collectively referred to as the Council Directors.
- The Council Directors will be elected by the SFC membership at the AMM on Sept 9<sup>th</sup>
- The Council Director will be responsible to: 1) sit on the SFC Board, 2) work with SFC to establish the respective Council, 3) Chair the respective Council, and 4) in collaboration with the respective stakeholder group, drive the direction and activity of the Council.

To nominate an individual for the above mentioned positions, please fill out the following form and return it to the SFC by August 26, 2023. All nominations require the signatures of two voting members of the SFC. Memberships will be verified. If memberships have lapsed, the nomination will be discarded.
