On behalf of the organizing committee and the Shooting Federation of Canada (SFC), we welcome all participants to the 2023 National Rifle Championship. For the first time in several decades, the championship will be held in Quebec at the Club sportif de la Mauricie.

This club has an air-conditioned compressed air shooting range of 10 shooting ranges and an outdoor range of 10 shooting positions for 50M events. The facilities are accessible to athletes with a disability (AWAD) and are equipped with SIUS electronic targets. During the competition, athletes will have the opportunity to obtain a "qualification score", according to the criteria established by the SFC.

The event will also serve as a selection event for SFC High Performance Teams (in accordance with the most recent version of the Athlete Selection Criteria posted on the SFC <u>website</u>). We are pleased to present an open national championship for all Canadian athletes, whether or not they aspire to become members of the national team. The Shooting Federation of Canada places great importance on the development of athletes of all ages and skill levels and believes that participation in high-performance competitions enriches the athletes' sport experience and advances individual performance. We would like to thank the many volunteers who put their time, expertise, and effort into making this competition possible. It would not have been possible to hold an event of this magnitude without their remarkable contribution. In particular, we salute the work of the members of the organizing committee who played a key role in the preparation of this competition: Gérard Michaud, Guillaume Paré, Michel Poitras, Sylvain Leclerc, Manon Normandin, Gale Stewart, Christian Jacques, Jean Delisle as well as volunteer members of the Club sportif de la Mauricie. ## 1. GENERAL INFORMATION

#### **1.1 Registration and Fees**

You must register and pay online on the Canadian Shooting Federation website here.

By using the online system and you will receive a confirmation email when the transaction is completed.

All international competitors will receive their invitation letter as soon as their payment has been received.

#### Registration deadline: June 15, 2023

It should be noted that mandatory administrative fees are not refundable in case of withdrawal.

After the deadline, registrations will only be accepted if there are places left and will be subject to a late registration fee of \$25, regardless of discipline.

The holding of the sporting and hunting rifle events will be conditional on at least 5 participants being registered. Competitors in those events must register, **before the registration deadline**, on the SFC website to determine if the events will be held. No registration will be accepted on site or after the start of the competition.

If the sporting and hunting rifles events are not presented for lack of participants, registrations will be refunded in full including administrative costs.

#### 1.2 Location of Club sportif de la Mauricie Range

The National Championship will be held in Trois-Rivières, Quebec, at:

The shooting range is about 1h15 from the Jean Lesage International Airport (YQB) located in Quebec City. It is also possible to arrive at Montréal-Pierre-Eliot-Trudeau International Airport (YUL). Depending on the traffic of Montreal's road network, it takes about 2h30 to get to Trois-Rivières.

We would like to point out that the shooting range is not served by public transportation and there will be no shuttle service between the hotels, the range, and the airport.

#### **1.3 Range Equipment**

Athletes must bring all the equipment they need. The shooting club does not provide the shooting mats.

#### **1.4 Accommodations**

#### **1.5 Transportation**

Participants are responsible for arranging their travel to the range and accommodation. It is possible to rent a vehicle at the Quebec City International Airport or the Montreal International Airport. Please check the websites of the 2 airports to find out the different providers available.

#### 1.6 Food

There are no restaurants located near the shooting range. However, it is possible to have meals delivered to the shooting range.

#### 1.7 SFC Membership

All competitors must be members in good standing of the Shooting Federation of Canada (SFC). The SFC National Office will verify that this is the case prior to the competition, during registration. All competitors must be able to provide proof of membership or must pay the membership fee at the time of registration.

Americans who are members in good standing of the NRA or USA Shooting for the year 2023 are not required to be members of the SFC.

Note: Athletes who are not Canadian citizens must provide proof of insurance valid in Canada or purchase an SFC membership with insurance included.

#### **1.8 Classifications**

Shooting Federation of Canada (SFC) members with a current, valid classification will compete in their respective class.

USA competitors with a current, valid USA Shooting classification card/digital passport for ISSF events or a current NRA classification for non-ISSF events will be placed in the equivalent SFC classification. All competitors are asked to register according to their true classification. This will be verified by the SFC National Office prior to the match. However, everyone must have proof of their classifications available at registration. This will be required of all athletes who do not pre-register.



Anyone not having a current SFC classification/USA Shooting classification for ISSF events nor a current SFC or NRA classification for non-ISSF events shall compete as:

(a) as a Temporary Expert for Sporting Rifle;

(b) as a Temporary Expert for all non-ISSF events;

(c) as a Temporary Master for all ISSF events; or

(d) for those with no classification that qualify according to age rules, may compete as a Veteran, International Junior or Sub-junior.

After shooting in one SFC match (1 full course) however, an American shooter will be assigned an SFC classification (at no charge) based on his/her scores in that match. He/She must use that classification in all subsequent SFC matches, or until he/she is reclassified, the same way as any SFC shooter. Please also refer to specific classification rules within each discipline section. There is no classification for the Hunting Rifle event. The Jury has the right to correct obvious mistakes.

#### Classifications :

Please tick the appropriate classification abbreviation when registering.

Note: A Veteran, Junior Intermediate or Junior shooter (who pays the full amount of the entry) may participate in all events, with the exceptions mentioned, and is eligible for all prizes, as specified, including awards in the "Veteran", "Junior Intermediate" and "Junior" categories.

Veterans must use the appropriate equipment to be eligible, i.e. no riflescopes. IN ADDITION, Veterans who have "stopped competing" are allowed to use their "old" equipment even if it no longer meets the current rules (they will then participate as Veterans only).



#### 1.9 SFC High Performance Athlete Selection Criteria

The criteria for the SFC High Performance and Identified teams can be found on the Shooting Federation of Canada website <u>here</u>. Attendance at 2023 National Championships is required to be eligible for any 2024 Shooting Federation of Canada team.

Athletes can shoot qualifying scores at the 2023 Canadian National Rifle Championships for the 2024 High Performance National and Development Teams (only those not currently on the 2023 High Performance Team), 2024 National Junior Team, and 2024 Identified Team. In order for scores to be eligible athletes must submit a QSDR <u>form</u> to the High Performance <u>portal</u> by July 2, 2023. Athletes must specify whether the first, second, or both courses of fire

The 2023 Canadian National Pistol Championships are also a qualifying event for both the 2023 Pan Am Games and 2024 Pan Am Championships. Both events are Paris 2024 Olympic qualifying events. Full details on the qualification process can be found <u>here</u>.

#### 1.10 Rules

The most recent rules published by the ISSF, including subsequent amendments,

interpretations and corrigenda posted on the ISSF website, will apply to all ISSF papers (including finals). Athletes and coaches are responsible for reviewing the ISSF Rules, which can be found on the website:

Sport rifle events will be governed by the current SFC rules for this discipline. With respect to the hunting rifle, the rules drafted by Red Bowes and updated by Robert Wood will apply.

The juries (equipment checks, classification and appeals) that will oversee the 2023 Canadian National Rifle Championship will be appointed by the Rifle Section.

Qualified shooting officials with appropriate licenses will lead the competitions.

For the use of air or CO2 cylinders only, see Regulation 6.2.4.2. of the ISSF rulebook, which states: "It is the athlete's responsibility to ensure that any air or CO2 cylinder used has not exceeded its validity date. This may be subject to inspection when checking the equipment.

Protests will be examined by the jury. Each protest costs \$25.00.

The jury's decisions are final.



#### 1.11 Rifle Section Meeting

In order to reach as many members as possible, the meeting of the rifle section will be held face-toface at the shooting range as well as virtually on August 5 at 6 pm or immediately after the end of the official air practice.

#### 1.12 Match Start Times

It should be noted that the times indicated in the program for the ISSF events correspond to the time of the first scoring shot.

For Sporting & hunting rifles the time mentioned in the program is the time of the first sighting shot.

Please note the schedule as specified in this program. As with all events, it is possible that certain circumstances may cause delays. Events will not start earlier than posted time, but they may start later. We therefore ask that you be ready at the indicated time.

#### 1.13 Special Notice of the Match Committee

In the event that a competitor's fired shots hit the electronic scoring target protection plate, the following penalty sequence shall be followed:

- First Occurrence: Yellow Card...Warning.
- Second Occurrence: Green Card...2 point penalty.
- Third Occurrence: Red Card...disqualification due to unsafe shooting practices.

The score that has been fired for record will be entered into the record sheets. No refund will be offered to the competitor.



#### 1.14 Safety

All pertinent firearms safety practices will be observed. Failure to follow safety rules or direction from Range Officers or Range Jury may be cause for disqualification and/or removal.

Eye protection is recommended for all competitors and officials on ranges while shooting is in progress. Any medical emergencies should be immediately reported to a range official.

The Organizing Committee and the Shooting Federation of Canada will not be responsible for any articles lost or stolen or any article left at the range during the competition.

No uncased rifle may be transported outside of the shooting range.

#### 1.15 Permits for International Competitors

Visitors to Canada who are bringing an air pistol or air rifle that has a muzzle velocity of less than 500 feet per second do not require permits. For visitors to Canada please see the RCMP website at: http://www.rcmp-grc.gc.ca/cfppcaf/index-eng.htm

Attention 'International' competitors: Please be aware, we DO NOT use any outside agents to sell registrations and/or VISAs to this event. If someone is offering this service, then it is an act of fraud which should be reported and we are in no way associated with such actions. Register ONLY directly with us. Each competitor is responsible for applying and obtaining any necessary travel VISAs and/or equipment applications for entry into Canada and unfortunately, we are NOT able to assist in this process in any way.

#### 1.16 Air Rifle/Pistol Propellant

Compressed air will be available for filling of rifle cylinders, but competitors must provide their own tank/cylinder adapters. If you require CO2 gas, you must provide your own.



#### 1.17 Smoking, vaping, Cannabis and/or Substance Use

Smoking and/or vaping is not permitted in any range, stats or scoring offices, any other closed room or tent, OR on any of the firing lines. Kindly go beyond the parking lot area if you must smoke or vape. Alcoholic beverages, cannabis use of any kind and/or any illegal substance use is not permitted on the premises at all.

#### 1.18 Anti-doping Controls

Anti-doping controls may be conducted by the Shooting Federation of Canada and the Canadian Centre for Drug-free Sport in accordance with ISSF and International Olympic Committee anti-doping regulations.

#### 1.19 Jurys and officials

Specific juries and officials' information will be posted on the range(s), as applicable.

#### 1.20 Results

Results will be posted on the SFC website as soon as they are available, after the conclusion of the entire event. They will also be emailed to participants using the email address on file with the SFC.

#### 1.21 Dress Code

All competitors, officials, coaches, volunteers and any other parties involved in this event must adhere to the ISSF Dress Code policy as attached hereto as Exhibit I. If this policy is violated in any way, please immediately make a formal report of such breach to the Match Director, the Chief Range Officer and/or the relevant Section Chair.

#### 1.22 Code of Ethics

All competitors, officials, coaches, volunteers, and any other parties involved in this event must adhere to the ISSF Code of Ethics policy as attached hereto as Exhibit II. If this policy is violated in any way, please immediately make a formal report of such breach to the Match Director, the Chief Range Officer and/or the Pistol/Rifle Section Chair.

**Behavior issues:** Please be aware that the Organizing Committee will not tolerate any abuse of any kind of our volunteers, officials, or competitors. If the organizing committee determines that such abuse has occurred or that the ISSF Code of Ethics has been breached, the organizing committee will eject any individual responsible for such abuse. The individual may be ejected from any venue utilized by the National Championship.

#### Notes

- The allocation of firing points will be carried out randomly.
- The schedule and composition of relays will be posted at the shooting range before the competition.
- Athletes will be called to the firing line 10 minutes prior to the start of the adjustment shooting period.
- The sighing time will be 15 minutes.
- The men's and women's 3-position rifle events will be contested simultaneously if the number of participants allows.

#### Teams

- In ISSF there will be 3-person teams in each of the following: ISSF Open and ISSF Junior Prone: mixed teams of men and women ISSF Men 3 Position, Junior 3 Position, Women 3 Position, Junior 3 Position, Men Air Rifle, Junior Men Air Rifle, Women Air Rifle, Junior Women Air Rifle.
- In Sporting Rifle there will 3-Person teams in each of the following: Open Prone, International Junior Prone, Open 3 Position, International 3 Position. In all team events Juniors can shoot on both the Open and Junior Teams if they have paid the adult fee.





#### 2.3 Finals

The finals of the ISSF events will be played in accordance with the ISSF rules currently in force.

In each ISSF event, the results of the final will be used to determine the podium. Results will be reviewed at the end of the match, and the results will be displayed. Junior athletes must pay the senior event fee to be eligible for the finals.

#### 2.4 Awards

There will be match prizes and category prizes in both men's and women's events. Junior athletes may compete for category and junior prizes if they pay the adult athlete fee. The number of awards per category will be based on the number of entries per category.

One or two shooters = one award.

Three or four shooters – two awards.

Five shooters or more = three awards.

International competitors cannot be declared the Canadian Champion, instead they will only be eligible for class awards

#### 2.5 Registration and Equipment Check

The equipment check will take place in the room located above the air range. According to the day and time indicated in the schedule.

## **6.7 COMPETITION CLOTHING AND EQUIPMENT**

## 6.7.5 ISSF Dress Code

It is the responsibility of athletes, coaches and officials to appear on the ranges dressed in a manner appropriate for a public sports event. Clothing worn by athletes and officials must comply with the ISSF Dress Code. See 6.20 for the full ISSF Dress Code.

#### 6.20 THE ISSF DRESS CODE

ISSF Rule General Technical Rule 6.7.5 states:

"It is the responsibility of athletes, coaches and officials to appear on the range dressed in a manner appropriate for a public sports event. Clothing worn by athletes and officials must comply with the ISSF Dress Code."

This Rule is the foundation of the ISSF Dress Code.

## 2023 Canadian National Rifle Championships

## Trois-Rivières, Quebec. August 2 to 10, 2023

In consideration of the Shooting Federation of Canada allowing me to take part as manager, coach, or athlete, or official in the 2023 Canadian National Rifle competitions, I hereby agree as follows:

- 1. To assume and accept all risks, dangers and hazards in connection with my participation in, and/or travel to and from, the Competitions;
- 2. To waive any and all claims that I may have against the Competition Director, The Shooting Federation of Canada, its directors, officers, employees, agents and representatives;
- 3. To release the Shooting Federation of Canada from any and all liability for any loss, damage, injury or expense that I, or my next of kin, may suffer or incur as a result of my participation in, and/or travel to or from the competitions, due to any cause whatsoever, including negligence or the part of the Competition Director, or officials;
- 4. To hold harmless and indemnify the Shooting Federation of Canada for any and all liability for property damage or personal injury suffered by myself or by a third party as a result to my participation in, and/or travel to or from the Competition.

I will immediately remove myself from participation in the Event and notify the nearest official, if at any time I sense any unusual hazard or unsafe condition or if I feel that I have experienced any deterioration in my physical, emotional or mental fitness, or that of my clothing, gear or equipment, for continued safe participation in the Event.

#### **Privacy Consent**
