#### GENERAL INFORMATION

#### 1. Registration

PRE-REGISTRATION IS REQUIRED. PRE -REGISTRATION WILL BE BASED ON FIRST COME, FIRST SERVED AND NO PRE-REGISTRATION WILL BE ACCEPTED WITHOUT PAYMENT IN FULL AT THE TIME OF REGISTRATION. REGISTRATION MUST BE RECEIVED NO LATER THAN April 15,2024

**Entries after the deadline** will be accepted only if space is available, permits can be obtained and are subject to a late registration fee of an additional \$US 50. There will be no registrations taken once the event has commenced

NOTE: ALL Non Bajian participants must complete and submit the firearms import permit (Appendix 1), Entry form(appendix 2), and Waiver (Appendix 3), Code of Ethics (Appendix 4) and pay fees April 15,2024. Airline arrival information is required to complete the permit.

#### 2. Travel to Barbados:

Please ensure your firearm complies with all airlines and connecting country rules for firearms transport and public health.

The Barbados Clay Target Association club has two overlapping International trap and skeet layouts as well as sporting clays ranges. Parking at the range is plentiful but please only park in designated area. All ranges are accessible for wheelchairs and mobility devices.

#### 4. Accommodations

Athletes are responsible for arranging all of their own accommodation. There are many other hotels available in the area. #### 5. Transportation

Athletes are responsible for arranging all of their own transportation to and from the Range and accommodation. Rental cars are available at the International Airport.

Since the cost of rental cars is quite high, we can help organize a group shuttle service for a fee for those competitors staying at Butterfly Beach hotels in the morning and returning

after shooting in the afternoon. If you want to participate in the shuttle service, please mention this in your pre-registration email.

#### <u>6.</u> Food

The Club will have food service will be available during PET and the competition. Water and snacks will be available throughout the competition.

#### 7. Membership

All competitors **MUST** be current members in good standing of their National Shooting Federation and be able to provide proof of membership.

#### 9. Rules and Regulations

The Trap and Skeetshooting events will be conducted according to the ISSF Rules and Regulations, currently posted in the ISSF website at <a href="www.issf-sports.org">www.issf-sports.org</a>. It is the responsibility of the athlete and coaches to be familiar with the current ISSF rules. The Sporting Clays event will generally follow the NSCA rules. Any alterations will be identified in the competitors meetings.

The Jury reserves the right to make exceptions to the Rules, procedures and times as and when necessary. All changes will be announced in writing and posted at the range and sent in What's App listing.

All shooters are expected to serve as sideline referees or flankers. If scheduled for the next round, there will be at least a 20 minute break between flanking and shooting. If an athlete fails to act as a sideline referee when he/she is required to do so, they shall be penalized as per the ISSF Rules.

An up-to-date program schedule (with changes to time or added information) will be posted and sent to What App list on site prior to the match.

Equipment control, if conducted, will be conducted according to the ISSF Rules and Regulation (9.4.1) using approved instruments.

**Targets:** The shooting range is equipped with international orange targets for qualification and flash targets for Finals.

**Machines**: Promatic target machines

**Protests:** Warnings/penalties will be given according to the current ISSF Official Statutes, Rules and Regulations. Protest forms will be available in the entry office. Protests will be handled by the Jury. Cost is \$50.00 each. The Jury's decisions are **final**.

**Finals**: Top 6 athletes from all classes will shoot qualifiers and medal matches according to the current ISSF Rules and Regulations format.

**Safety**: All pertinent firearms safety practices will be observed. Failure to follow safety rules or direction from Officials or Jury may be cause for disqualification and/or removal.

**Eye protection and ear protection** is mandatory for all competitors and officials on ranges while shooting is in progress. Any medical emergencies should be immediately reported to a range official. Procedures will be posted

**Code of Ethics:** All competitors, officials, coaches, volunteers and any other parties involved in this event must adhere to the ISSF Code of Ethics policy. If this policy is violated in any way, please immediately make a formal report of such breach to the Match Director.

**Behavior issues**: Please be aware that the Organizing Committee will not tolerate any abuse of any kind of our volunteers, officials or competitors. If the Organizing Committee determines that such abuse has occurred or that the ISSF Code of Ethics has been breached, the Organizing Committee will eject from the competition any individual responsible for such abuse. The individual may be ejected from the shooting venue

**General requirements**: Non-medical use of drugs or the consumption of alcohol is not permitted during the competition.

The Organizing Committee will not be responsible for any articles lost or stolen or any article left at the range during the competition.

#### **10.** Awards

Only one (1) award per event can be awarded to an individual. In a situation where an athlete qualifies for more than one award, the highest placing will be awarded to the athlete.

All awards will be presented after the competition has concluded. Top three athletes and class awards will be presented at the conclusion of the event

#### 11. Ammunition

RC 2 Ammunition available and practice rounds will be paid for at the time of practice. By law, all ammunition and firearms must remain on the range. Remaining partial boxes of ammunition will be donated to the BCTA Junior program.

#### 12. Entry Process

Pre-registration and payment are required before April 15,2024. Please use the Entry Form attached to this program (Appendix 1) and email it to <a href="mailto:smhonour@gmail.com">smhonour@gmail.com</a>. We can take credit cards or etransfers that will be arranged by phone.

If you are unable to attend, entry fee refunds are only available until May 5, 2024. No refunds are available for gun import permits. A \$50 Administration fee will be withheld on any requested refunds. Hotel reservations are not a part of this process.

Registration will be limited to a maximum of thirty (30) competitors in each event.
